## FINANCE and ADMINISTRATION

Commissioner Hunter had no additions to written report. Mayor Gardner that a report of the 1st draft from the auditors shows that approximately \$40,000 will be applied to the fund balance. Within the next 60 days we will get the final report from the auditor.

## PUBLIC WORKS

Commissioner Harding had no additions to written reports.

## PUBLIC SAFETY

Commissioner Hardy reported in addition to written reports, traffic stops have gone smoothly. Quilter's Lane Committee was approached by the Arts Council, they applied and got approval for an \$1100 grant that requires a 50/50 match. Commissioner Blalock asked if Town budget could find the funds necessary. Mayor Gardner asked Commissioner Hardy to come up with a proposal on what Quilters Lane would like to do and present it to the Board by November for their consideration. A discussion was held on adding a link to Town website for Quilter's Lane and creating a Quilter's Lane Facebook page. Fireman's Day is scheduled for September 23, 2017.

## HUMAN RESOURCES/INFORMATION TECHNOLOGY

Commissioner Blalock had no report. Public Works Director was asked the condition of Kenny Champion and he replied more will be known after doctor's appointment Friday.

## **REVITALIZATION/HISTORICAL**

Commissioner Coffman had no report from the Historic District Committee. Revitalization is discussing a possible Blues Concert in early 2018. Movie Night is looking good and flyers are circulating. Cheryl Reddish, Warren County Librarian, has been very helpful with project (purchasing films etc). Harvest Market has received \$1200 in sponsorship funds (First Citizen Bank -CenturyLink -United Healthcare). Music will be performed by Jimmy Weaver Trio. The NCDOT Bicycle and Pedestrian Planning Grant was discussed (a 90/10 grant). The notion of creating a countywide bike ride much like what is located in Williamsburg, VA or Emerald Isle areas was discussed.
