Vendor fee is **\$30.00** per space for merchants and \$60.00 per space for food trucks; spaces are approximately 10'x10' each; please indicate if you want two spaces and include the fee for each. Fee must be paid by check or money order and accompany this application.

There will be no refunds.

Vendor set-up is from **7:30** am to **9:30** am; vendors are expected to be festival-ready by **10:00** am and remain until **4:00** pm.

The Festival Committee reserves the right to accept or reject any application.

**Please bring your own canopy; we do not supply them and you may NOT be in shade!**

Sorry! **Electricity is NOT available!**

There is no charge for government agencies. Non-profits will be charged a vendor fee.

**After set-up, vendor parking will be in the Warren County employee lot behind the Courthouse across Front Street.**

**FOOD VENDORS PLEASE NOTE** — The Warren County Environmental Health Department is enforcing new rules. Food vendors who do not have a state license will need to obtain a Temporary Food Application from the Health Department 15 days in advance of the event. You may not obtain one on the day of the event. Representatives of the Health Department will be checking licenses, and any food vendor without a license will not be allowed to set up or sell at the Festival.
